The meeting will offer the DCF membership the opportunity to learn about all aspects of the proposed Navitus Bay Windfarm in order to develop a clear understanding of what is proposed and the potential social, economic and environmental opportunities and impacts. Speakers include Alan MacDonald from Architech, author of 'Windfarm Visualisations Perception or Perspective', David Mudie, Highland Council and David Haughian, Lead Officer for Walney Offshore Windfarm, Cumbria County Council

Road Safety concerns Lindsay Road/St Aldhelm's Road Junction & Lower end of Wilderton Road: An inaugural Community Speed Watch public meeting is being held on Wednesday 19th June, at the Holy Angels Church Hall, Lilliput Road at 7pm. This clashes with the next Canford Cliffs & Penn Hill Area Committee meeting.

Sustaining Poole's Seafront (Formerly Seafront Beach Master Plan DPD): JS reported that Cllr Elaine Atkinson and Cllr Judy Butt have received advice from the Borough Solicitor regarding the Poole Corporation Act 1986 and hope to sign off the decision in the next week or two.

William Mutlow expressed his concerns about the presentation at the Association's recent AGM.

Firstly, in regard to the £7m needed, the word 'ring fencing' was never used in terms of generating this money. As the beach area is 'the Jewel in the Crown' of Poole for both residents and visitors, and if it so important for future generations, WM is concerned that no money towards its upkeep has been ring-fenced by Poole Council.

Secondly, in his comments on one of the sites by the Head of Planning & Regeneration, made no reference to the number of storeys. Some ten years ago, the former Head of Planning & Design sought to limit the height of buildings to no

more than three storeys, but now seven storeys are acceptable. WM's concern is where is this going to end up?

Chairman's note: Extract from item in Daily Echo dated 09/05/13

"...Improvements are being carried out at some of the beach toilets in Poole to ensure they are ready for the summer season.

Loos at both Branksome Chine car park and Branksome Chine Promenade are having a new power supply connected following an electrical fault at the start of the vear.

The car park toilets are still open but the promenade toilets are closed, however visitors can also use those at Canford Cliffs promenade.

Work is also being carried out to old single pumps along the prom, which have a high risk of failure at peak times, after members allocated £250,000.

Branksome Dene Chine toilets are closed until May 24 while a new pumping station is built. Temporary toilets are available for anyone booked into the community room.

A new pumping station is also being built close to toilets at Flaghead Chine. Work began on April 20 and it is hoped the toilets will only be closed May 20-24."

Membership recruitment drive: JS said that the delivery of the Spring 2013 magazines via the Royal Door-to-door service did not prove to be an unqualified success. It has been reported to JS that, in two cases, magazines were delivered to blocks of flats as a single item, rather than to each individual flat and magazines were not delivered to number of addresses.

Waste collection: JS said that this was debated at last Thursday's Environment Overview and Scrutiny Committee meeting.

MH said that it had been decided not to change the current situation where refuse will not be collected over the Christmas and New Year period. This period of noncollection will change each year as the dates for Christmas and New Year change and thus the same residents will not be affected all of the time. May went on to say that when she has the dates of the collections for 2013 she will do her best to publicise them, as well as dates being available on the BoP website and in the Poole News: perhaps the Minutes of this Association and the various Notice Boards.
